Mike Cupp – Mike reviewed with council the protocol they want in place regarding spending money from the police account. Mike would like to have the city clerk move \$1000 from the police account into the general fund at the beginning of every month. This will cover police salaries and gas. Deana Despaw stated she would like to see a baseline balance in that account of \$2000 for emergencies. Tarena Hill stated she would like Mike to get council's approval for any purchases of \$5000 or over. Mike agreed to both suggestions. Mike then informed council he would like to order the following items for his police vehicle: headlight flashers, Sound Off Enforcer light bar, 400 series siren with speaker, Hadis console, rear taillight flashers, rear license plate lights, rear quarter panel glass lights and a push bar. Total cost is approximately \$7100. Tarena Hill made a motion to approve Mike's request for \$7100 to purchase equipment for his police vehicle. Vonda Barela 2nd. All agree, motion passed.

Michael Hatcher – Michael informed council the wastewater pump truck is currently down due to the water pump needing replacement. Parts will cost about \$150. Since both trucks are now in the shop, the city has been using the Mayor's personal vehicle. Tarena made a motion to pay for the gas in the Mayor's truck. Deana Despaw 2nd. All agree, motion passed.
